

### PFAS contamination and tort law challenges - mapping a developing field of damages

On 28 March 2025, the PREST research group (Private Enforcement, Sustainability & Technology) at the Faculty of Law is organizing a morning seminar on so-called 'forever chemicals' (PFAS - per- and polyfluoroalkyl substances) and damages liability.

We have the pleasure to welcome Johanna Chamberlain as a speaker, Associate Professor and Senior Lecturer in Private Law, Faculty of Law at Uppsala University, Sweden.

### Abstract

Contamination harms have always raised special difficulties, both in the environmental law and tort law context. With multiple potential tortfeasors typically being the case and widely spread harm that is often realised decades after pollution has occurred, issues of for instance adequate causality, limitation and compensable harms become particularly complex. This is the case not least when it comes to a type of contamination that has been gaining increasing attention recently, namely damages pertaining to PFAS or "forever chemicals".

The seminar will focus on the tort law issues sparked by PFAS contamination and how these can be handled in primarily Swedish law today, building on ongoing case law developments. The discussion will touch both on possible routes to compensation for injured parties and what challenges come with different bases for liability, as well as the confrontation between traditional tort law principles and prerequisites and the special features of contamination harms. Does the nature of these damage claims demand adaptation and nuancing of our classic understanding of tort law, if the compensatory and preventative purposes of tort law are to be fulfilled also when it comes to victims of PFAS harms?
